RESOLUTION NO.

RESOLUTION FINDING THAT, AS A RESULT OF THE CONTINUING COVID-19 PANDEMIC STATE OF EMERGENCY DECLARED BY GOVERNOR NEWSOM, MEETING IN PERSON FOR MEETINGS OF THE JUVENILE JUSTICE & DELINQUENCY PREVENTION COMMISSION (JJDP) WOULD PRESENT IMMEDIATE RISKS TO THE HEALTH OR SAFETY OF ATTENDEES

WHEREAS, on March 4, 2020, the Governor proclaimed pursuant to his authority under the California Emergency Services Act, California Government Code section 8625, that a state of emergency exists with regard to a novel coronavirus (a disease now known as COVID-19); and

WHEREAS, on June 4, 2021, the Governor clarified that the “reopening” of California on June 15, 2021 did not include any change to the proclaimed state of emergency or the powers exercised thereunder, and as of the date of this Resolution, neither the Governor nor the Legislature have exercised their respective powers pursuant to California Government Code section 8629 to lift the state of emergency either by proclamation or by concurrent resolution in the state Legislature; and

WHEREAS, on March 17, 2020, Governor Newsom issued Executive Order N-29-20 that suspended the teleconferencing rules set forth in the California Open Meeting law, Government Code section 54950 et seq. (the “Brown Act”), provided certain requirements were met and followed; and

WHEREAS, on September 16, 2021, Governor Newsom signed AB 361 that provides that a legislative body subject to the Brown Act may continue to meet without fully complying with the teleconferencing rules in the Brown Act provided the legislative

body determines that meeting in person would present imminent risks to the health or safety of attendees, and further requires that certain findings be made by the legislative body every thirty (30) days; and,

WHEREAS, California Department of Public Health (“CDPH”) and the federal Centers for Disease Control and Prevention (“CDC”) caution that the Delta variant of COVID-19, currently the dominant strain of COVID-19 in the country, is more transmissible than prior variants of the virus, may cause more severe illness, and that even fully vaccinated individuals can spread the virus to others resulting in rapid and alarming rates of COVID-19 cases and hospitalizations (<https://www.cdc.gov/coronavirus/2019-ncov/variants/delta-variant.html>); and,

WHEREAS, the CDC has established a “Community Transmission” metric with 4 tiers designed to reflect a community’s COVID-19 case rate and percent positivity; and,

WHEREAS, the County of San Mateo currently has a Community Transmission metric of “substantial” which is the second most serious of the tiers; and,

WHEREAS, the JJDPC has an important governmental interest in protecting the health, safety and welfare of those who participate in its meetings; and,

WHEREAS, in the interest of public health and safety, as affected by the emergency caused by the spread of COVID-19, the JJDPC deems it necessary to find that meeting in person would present imminent risks to the health or safety of attendees, and thus intends to invoke the provisions of AB 361 related to teleconferencing;

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that

1. The recitals set forth above are true and correct.
2. The JJDPC finds that meeting in person would present imminent risks to the health or safety of attendees.
3. Staff is directed to return no later than thirty (30) days after the adoption of this resolution with an item for the JJDPC to consider making the findings required by AB 361 in order to continue meeting under its provisions.
4. Staff is directed to take such other necessary or appropriate actions to implement the intent and purposes of this resolution.

f. **Update on Membership:**

Mama Dee’s candidacy for Commissioner is subject to approval by SMC BOS to waive the 12 year limitation on serving on the Commission (Mama Dee served as a Commissioner on the JJDP for 12 years, over 10 years ago).

II. Oral Communications (Public Comment): none made at this time.

III. Update from Sacramento (Chief John Keene). Chief Keene provided an overview of the current process of decentralization of the juvenile justice system in California (SB 823), and his work as both chief of probation and as current President of the Association of Probation Chiefs in California, liaising with BSCC and OYCR.

IV. System Updates and Trends:

a. **Juvenile Court (Cadet).** Court is continuing as normal, except that mask mandate has been reinstated in all courthouses in SMC. Commissioners were thanked for their service and encouraged to attend court as it is important for youth to see this support in the courtroom.

b. **Legislative Update (Huber-Levy, Liu).** Commissioner Liu provided a summary of the status of current bills relating to juvenile justice in California; a copy of the summary was provided to Commissioners prior to the meeting and is appended to these minutes.

c. **BSCC Regulations Review (Colin Ford, Policy Advisor - FLY).** Mr. Ford provided an overview of the regulation revision process currently being conducted by the BSCC (Board of State and Community Corrections - the regulatory agency overseeing probation departments and locked facilities in CA, adult and juvenile). These Title 15 & 24 regulations provide minimum standards for all aspects of locked facilities, and it is important that they be updated regularly to ensure youth have access to appropriate services and to protect their rights. The BSCC provided grants to three different CBOs (in southern, central, and northern CA (FLY)) to allow community input at accessible listening sessions, and through surveys. The final report will be presented to BSCC on September 1, 2022, and will include specific recommendations. A copy of the report will be provided to the JJDPC and Mr Ford will return at a future meeting to update the Commission.

d. **Probation (Stauffer)** – currently there are 16 deputy probation officers in juvenile division:

Status of Youth on Probation:

- Intake Unit (Assessment for Diversion/Investigations): 189– with 29 new referrals in June:
 - 7 youth assessed for diversion or contract (letter of reprimand, victim impact awareness program; assessment with BHRS clinician for eligibility for 3/6 mo. contract; petty theft program)
 - 2 youth referred out to Youth Outreach Program
 - 16 youth referred to DA’s office (mandatory send to DA – prior probation, terminated and new offense)
- Supervised Probation: 122 (formal & informal)
 - Placement: 0
 - With Gang Conditions: 10 (intensive probation)
 - Non-Minor Dependent Status: 5 (AB12 services - previously in placement, now receiving extended foster care with funding and services)
- Informal Diversion Contracts: 5
 - 90 day contracts: 2; 6 month contracts: 3
- Electronic Monitoring (EMP): 18 (pre-disposition youth and youth on probation)
- DJJ: 1 – note: already have had 4 youth return from DJJ to supervised probation in SMC
- 60% Hispanic/Latino; 11% Black/African American; 12%White; 7% Other; 6% Hawaiian/PI; 3% Asian; 1% Unknown

Status of Youth at Institutions, Youth Services Center/Camp Kemp (Clark): 17 youth in custody:

- **YSC:** 15 (male youth)
- **Camp Kemp:** 4 (female youth: 1 from Sonoma County, 3 from SMC); 2 girls attending Girls Empowerment Program (GEP) daily.
- 63% Hispanic/Latino; 11% Black/African American; 4%White; 11% Other; 11% Hawaiian/PI.

Total youth in SMC juvenile justice system: 321(57 female/264 male youth) (last month: 308)

c. HSA, Children and Family Services (Fong)

Mr Fong provided a written update on relevant metrics to the meeting (attached to agenda packet).

V. Commission Updates & Actions:

a. PeerPoint Youth Diversion Project (Huber-Levy, Newton)

Commissioner Newton provided an update on funding raised in support of launching PeerPoint, and on the status of transitioning the funding and fiscal sponsorship for PeerPoint to be operated by FLY in SMC.

b. California Association of Youth Courts (Liu):

Commissioner Liu attended several sessions of the recent National Council on Juvenile and Family Court Judges (NCJFCJ) conference as an exhibitor representing CAYC and shared some insights on viewing substance abuse as chronic illness, and the availability diverse solutions available for early stage intervention with adverse child experiences.

c. Diversion Programs (Swope):

Commissioner Swope will be reaching out to elected and appointed officials to promote awareness of and access to the Diversion Programs report completed recently.

d. Gang Intervention and Prevention Project (Labouisse):

Have conducted meetings with community organizations and doing outreach to learn more. Will be meeting with “Live in Peace”, an EPA organization, to learn more about their work. The project is still in the research phase, gathering data and setting up interviews with people who have knowledge of gang activity in the county.

e. Arts Grant for YSC (Bocanegra):

Commissioner Bocanegra is staying in touch with Ms Rodricks of the County Office of Arts & Culture regarding applying for a Jump StArt grant from the CA Arts Council to fund arts programs for YSC.

f. Marketing & Social Media (Labouisse for Rasmussen):

Social media presence on Twitter and Instagram continues to grow; JJDPCC meetings are uploaded to YouTube and available to public to watch. Please follow JJDPCC on Twitter and Instagram.

V. New Commission Projects

a. Update on Commission Retreat/Offsite (Labouisse): Date is set for Saturday, August 20th for an in person meeting for Commissioners; the County will be providing a facilitator, Debbie Schechter, who is very experienced in providing team building and facilitation through PCRC and for County departments and commissions. Location tba, but will be somewhere in Redwood City or Central San Mateo.

b. CPPCA Conference (Huber-Levy): California Probation, Parole & Correctional Association Organization is holding its 89th annual training conference being held in Newport Beach, CA on September 6-9. A morning of training is being offered to JJDPCC Commissioners on Thursday, September 8th. As there would be a registration fee and costs associated with travel to this training, Chair Labouisse agreed to include this in the topic of budget requests for the BOS.

Subject: Request to Adopt Ordinance for Civilian Oversight of the Sheriff's Office, per AB 1185, and as Proposed by Fixin' San Mateo County

Dear Board of Supervisors,

The Juvenile Justice and Delinquency Prevention Commission supports the efforts of a nonpartisan local grassroots community group, [Fixin' San Mateo County](#) (FxSMC), to establish effective and independent civilian oversight of the San Mateo County Sheriff's Office, and voted at our August 30, 2022 meeting to urge the Board of Supervisors to use its legislative authority under [AB 1185](#) to enact a strong and independent Civilian Oversight Board and Inspector General office, both with subpoena power.

Independent and effective civilian oversight promotes good government and fiscal responsibility. Civilian oversight of law enforcement has proven effective in protecting civil rights and ensuring transparency and accountability. The approach proposed by Fixin' San Mateo County will build more positive relationships between the community and the Sheriff's Office. The juvenile justice system's goal of positive youth development and rehabilitation would be supported by such civilian oversight.

Sheriff's deputies are often the first point of contact with youth. The vast majority of youth in the juvenile justice system have experienced childhood trauma resulting in mental health and substance abuse issues, and we believe that a Sheriff's Office with civilian oversight is less likely to traumatize the County's youth further during law enforcement contacts. Furthermore, engaging youth in a positive way with Sheriff's Office programs can help them make positive choices to lead healthy and productive lives, and reduce the likelihood of re-offending.

To date, over 220 cities and counties nationwide have created Citizen Oversight Boards to monitor law enforcement agencies, 25 in California alone.

San Mateo County should join this rapidly growing movement.

There is public support for civilian oversight. Fixin' San Mateo County has earned the endorsement of all five federal and state elected officials – Representatives Anna Eshoo and Jackie Speier, State Senator Josh Becker, and Assemblymembers Marc Berman and Kevin Mullin – as well as more than 13 Mayors and former Mayors and other local elected officials, faith leaders, and community leaders and organizations.

Please use your legal authority as our elected officials to enact a strong and independent Civilian Oversight Board and Inspector General office.

George Culores Hall of Fame presented each February

Tony Hoffman Community Mental Health Service Award presented in May.
